भारतीय कृषि अनुसंधान परिषद (ICAR) के कार्यालय ज्ञापन (O.M.) संख्या F. No. Admn.10-1/2025 - R&P दिनांक 1 मई, 2025 में जारी दिशा-निर्देशों के अनुपालन में, अनुकंपा नियुक्ति के आवेदकों की एक समेकित डेटा शीट तैयार की गई है। यह डेटा, जो 100-अंकों के पैमाने (100-point scale) के तहत अंक देने का आधार है, संस्थान के आधिकारिक रिकॉर्ड के साथ मिलान करके संशोधित/सुधार दिया गया है।


**Subject: Uploading of Consolidated Data Sheet for Compassionate Appointment – reg.**
